### **Introduction to Platt College San Diego Policy on Published Crime Statistics**

According to a federal law known as the "Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act", our school is required to disclose statistics concerning the occurrence of certain criminal offenses reported to law enforcement agencies or to an official of the school. This report is prepared in cooperation with the local law enforcement agencies surrounding our campus and includes data from calendar year 2019. In 2006 the City of San Diego has enabled access to their ARJIS Crime Statistics and Maps on their website. Information can now be obtained for crime events in the immediate neighborhood surrounding the campus via the map searches. These statistics include crimes that have occurred in public areas and businesses in the College Area neighborhood (specifically 6200 to 6300 El Cajon Blvd., and 4800 to 5100 63<sup>rd</sup> Street.)

The criminal offenses for which we are required to disclose statistics are murder/non-negligent manslaughter, negligent manslaughter, sex offenses (forcible and non-forcible [incest, statutory rape]), robbery, aggravated assault, burglary, motor vehicle theft, arson, liquor law/drug abuse violations, and weapons (carrying, possessing, etc.) We are also required to report statistics for bias-related (hate) crimes related to race, religion, sexual orientation, gender, disability, or ethnicity and Violence Against Women offenses.

The school publishes crime statistics for the prior three years. The data is gathered from the annual Campus Crime Surveys, printed on school letterhead in table form, and distributed to students, employees, and applicants. A copy of the school's statistics report for 2017, 2018, and 2019 is attached.

# <u>Platt College San Diego Policy Regarding Procedures to Report Criminal Actions or Emergencies on Campus and on Timely Warnings</u>

To maintain a safe campus environment, Platt College San Diego requests that you alert school administrators of any criminal or potentially dangerous situation near the school. The school officer will inform the campus community and take appropriate precautions to help prevent similar crimes. In the event a situation arises, either on campus or in the immediate surrounding area, that, in the judgement of school administrators constitutes an ongoing or continuing threat, a campus wide "timely warning" will be issued. The warning will be issued though the college email system to students, faculty, and staff. Depending on the circumstances of the event, especially in all situations that could post an immediate threat to the community and individuals, the San Diego Police will be notified. A notice will be posted on every classroom door and at each stairwell on campus.

If you witness a crime or potentially dangerous situation on or near the Platt College San Diego campus (which may or may not warrant a Timely Warning to be issued) immediately report the circumstances first to the San Diego Police (dial 911) and second to a school administrator by phone (619-265-0107), email, or office visit. ### Platt College San Diego Policy Addressing Security/Maintenance and Access

There are no residential facilities at Platt College San Diego, thus this policy section relates to the security/maintenance of, and access to, classrooms, labs, offices, and parking areas on campus.

The Platt College San Diego campus will be open to students and employees Monday through Friday from 7:45 am to 5:00 pm. Gates will be locked at all other times, accessible by authorized key and alarm code holders. The facilities are protected by a security alarm/monitoring service and security camera systems. While the campus is open, all guests must report to an administration office, room 204 or at 6248 El Cajon Blvd. The receptionist or other staff member will direct the guest to the correct destination. Under no circumstances shall an unscheduled visitor be allowed to interrupt a class in session. The facilities manager has the authority to detain, apprehend, and initiate arrest of anyone involved in illegal acts on campus. The offense will be reported to the San Diego Police for prosecution. During daytime hours, the San Diego Police and a school official must be notified if a dangerous situation is observed.

The facilities are maintained with security considerations in mind. Pathways around classrooms and administrative areas, as well as campus parking lots, are well lit and kept clear of obstacles. If parked off-campus, students or employees may request an escort to their vehicle by the facilities manager or ban instructor. If a hazardous situation is observed on campus, a school officer must be notified immediately. The officer will take measures to prevent accidents (post hazard signs, rope off a dangerous location, etc.) and will facilitate corrective action as needed. You will be asked to complete and submit an appropriate report form.

### Platt College San Diego Policy Addressing Alcoholic Beverages and Illegal Drug Possession

The possession, sale, manufacture, or distribution of any controlled substance is illegal under both federal and state laws. These activities are prohibited on campus and the San Diego Police Department provides strict enforcement of alcohol and drug laws. Violators are subject to disciplinary action, criminal prosecution, fine and imprisonment in accordance with those laws. Additionally, students who abuse this campus policy will no longer qualify for participation in the Title IV student loan programs.

# Platt College San Diego Policy Addressing the "Violence Against Women Reauthorization Act" of 2013 and the Prevention of, and Response to, Sex Offenses

Education about sexual assaults (forcible or nonforcible), domestic violence, stalking, dating violence, and rape can be obtained from the San Diego Police Department. If you are a victim of a sexual assault, your first priority should be to get to a place of safety. You should then obtain necessary medical treatment. A victim of sexual assault should report the incident in timely manner to the local police department and if on campus, to a Platt College San Diego administrator. Time is a critical factor for evidence collection and preservation. Filing a police report will not obligate the victim to prosecute, nor will it subject the victim to scrutiny or judgmental opinions. Filing a police report will: 1) ensure that a victim of sexual assault receives the necessary medical treatment and tests, at no expense to the victim; 2) provide the opportunity for collection of evidence helpful in prosecution, which cannot be obtained later; 3) assure the victim has access to confidential counseling from counselors specifically trained in the area of sexual assault crisis intervention. A student found guilty of violating the campus sexual misconduct policy will be criminally prosecuted and will be expelled from the college.

The Campus Sex Crimes Prevention Act of 2000 is a federal law that provides for the tracking of convicted sex offenders enrolled at, or employed at, institutions of higher education. #### **Collecting and Reporting of Crime Statistics**

Platt College San Diego collects and maintains documentation regarding crime statistics and annually discloses that information in its Annual Security Report (ASR) and Campus Safety and Security Survey. This information specifically identifies crimes of violence against women, rape, dating violence, domestic violence, sexual assault and stalking. The information is distributed to employees and students annually and posted on our website.

#### **Policies and Procedures for Reporting Crimes**

The following procedure does not supersede an individual's judgement or right to notify the police of any criminal activity.

Whether the police are notified or not, victims or witnesses of crimes or suspicious activity that take place on the school campus, in its immediate geographic area or at a school activity are encouraged to report the crime to a teacher, staff member or other school official. They may do so confidentially.

The school official must first ensure the safety and wellbeing of the victim and / or witness. Next, relevant information regarding the incident should be obtained. As soon as possible the school official should initiate the CRIME REPORT FORM with one of the following personnel: Facilities Manager (Christian Pulley) or Vice President / School Director (Al Medro). During the process of completing the CRIME REPORT FORM, additional evidence or

information will be obtained. Reports are kept in a secure location within the controller's office and a digital copy is maintained by the facilities manager. It is the policy of Platt College San Diego to document and report criminal acts to the local authorities as required by law.
